Vice Chair Brannon made some announcements on behalf of some of the local arts groups:

Actors Conservatory Theatre will be performing *Madagascar* on March 31st & April 2nd, and will be performing Disney's *Descendants*, the Musical, May 5th - May 7th. The Voices of Flower Mound will have their Spring concerts on May 6th & May 7th. Flower Mound Community Orchestra has concerts coming up: April 18th at the Library and April 25th at Trietsch Memorial United Methodist Church, as well as *Peter and the Wolf* which will also be at Trietsch.

Lewisville Lake Symphony has concerts coming up on March 24th, April 12th, and April 13th. They will also be performing April 14th at the Lewisville Grand.

Our Productions Theatre Company will be performing *You're a Good Man Charlie Brown* April 7th & 8th also at the Lewisville Grand.

D. STAFF/DIRECTOR REPORT

Tish Carter, Community and Cultural Events Manager, reported upcoming developments. She informed the Commission that the Town Hall Art Display is set to change to feature a new artist, Tracy Hooper, a Flower Mound Police Officer. Tish stated that the Traffic Signal Box Art Project had three winners out of the 18 applications that were received this year. The Arts Festival at Heritage Park is coming up in 5 weeks on Saturday, May 13th. Tish informed the board that the Community Mural is developing.

Sue Ridnour, Director of Library Services, went over the highlights for the budget prep for the 20222023 Fiscal year. Sue then went over some of the upcoming programs that will be at the library as follows:

Green Acres Park in combination with iNaturalist Photography Exhibit and Elm Fork Chapter of Texas Master Naturalists will be displaying some of their work at the Library from April 1st -- May 25th.

We will be demonstrating how to use the Cricut machine to make Felt Flowers on Monday, April 3rd at 7pm, for which all supplies are provided. Registration for this will be on the website. Photography workshop on April 11th at 7pm. Registration for this will be on the website.

The Flower Mound Philharmonic Orchestra, an ensemble group of the Flower Mound Community Orchestra (FMCO), will be performing at the Library on Tuesday, April 18th at 7pm. For this Registration is not required.

Howard Garrett The Dirt Doctor will be at the Library on Monday, April 24th at 6:30pm. This will be in partnership with the Town's Environmental Services. Registration for this will be on the website.
