I. CONSENT ITEM(S)

1. Minutes of September 23, 2024 - Consider approval of the minutes from September 23, 2024.

J. NON-DISCRETIONARY ITEM(S)

This part of the agenda consists of items that are in compliance with all applicable development standards; are not requesting waivers, exceptions, or deviations, and do not require a Public Hearing.

1. SP23-0010 - Embree Whataburger - Consider a Site Plan (SP23-0010- Embree Whataburger) to develop a fast-food restaurant with a drive through window. The property is generally located west of Long Prairie Road and south of Sagebrush Drive.
2. SP24-0011 - Auto Zone Flower Mound Road - Consider a request for a Site Plan (SP24-0011 – Auto Zone Flower Mound Road) to develop a retail building. The property is generally located north of Flower Mound Road and west of Long Prairie Road.

The property is generally located north of Cross Timbers Road and west of Long Prairie Road.
