D. PRESENTATIONS

1. **The Quakertown Story - Karyn Blucker**
Historian and author Karen Blucker presented an overview of Quakertown, a community established in the late 19th century near Denton. Her presentation highlighted the community's development, local businesses, civic institutions, and notable residents, as well as the events that led to the community's relocation in the early 20th century. She also discussed ongoing efforts to preserve and share Quakertown's history, including the Quakertown House Museum, historical markers, public art installations, educational resources, and archival collections. The presentation recognized the contributions of community leaders, residents, and descendants whose stories continue to help document and preserve Quakertown's legacy.
2. **Flower Mound Then and Now - Terra Klarich**
Commissioner Klarich presented a condensed version of an educational "Then and Now" presentation and introduced a community outreach program designed for schools, scout groups, and other community organizations. The presentation highlighted key aspects of Flower Mound's history, including early settlement, Indigenous heritage, community development, and notable local landmarks such as Flower Mound Presbyterian Church and Cemetery, the Donald School, and Marcus and Flower Mound High Schools. She also discussed the history of the Gibson-Grant Log House, the library, and the fire department, while noting that the Town's oldest known standing structure dates to the 1860s. The presentation incorporated historical and contemporary perspectives to illustrate Flower Mound's growth and evolution over time.
