2. *RC16-0020 – Hawks Hill Addition*

Consider a request for a Record Plat to create a three lot subdivision. The property is generally located at the southwest corner of Waketon Road and Long Prairie Road.

3. *SP17-0004 – Flower Mound Town Hall*

Consider a request for a Site Plan to develop a new Town Hall, with an exception to Section 82-242, "Street buffer landscaping," of the Code of Ordinances. The property is generally located south of Cross Timbers Road and east of Morriss Road.

4. *ZPD17-0001 – Lakeside Crossing*

Public Hearing

Public Hearing to consider a request for rezoning from Agricultural District (A) and a portion of Planned Development District No. 31 (PD-31) to Planned Development District No. 153 (PD-153) for both residential and non-residential uses in compliance with the Campus Commercial land use designation within the Lakeside Business District Area Plan, including a Comprehensive Sign Package, with certain modifications and exceptions to the Code of Ordinances, and with an exception to the Architectural Standards of the Town's Urban Design Plan for meritorious design. The property is generally located south of Lakeside Parkway along and between Long Prairie Road and Northwood Drive.
